General Instructions

- Service Bylaws of NHM 2018 will be applicable for this post.
- The contract period of this post is initially upto 31-03-2024 which may be extended as per sanction received from office of M.D. NHM Haryana, Panchkula.
- The candidate should give details of all the examinations passed from Matriculation or its equivalent onwards and mention total and percentage of marks obtained and maximum marks in each examination. The candidates are advised to attach self-attested photocopy only of essential qualification certificates/diploma/degree with the application form. Application form should be complete in all respects duly filled in by the candidates in their own handwriting in capital letters and signed by the candidate.
- **All Communication will be done on Official website www.nhmsirsa.org**
- Selection will be made as per letter no NHM/Admin/HRC-1/2022-23/10885-905 dated 20-03-2023(Attached).
- It is mandatory for staff to maintain H Q and reside at the Place of Posting.
